Minutes of Vestry Meeting St.Lukes Episcopal Church Fine Creek Mills, Va.

January 7,1957.

The Vestry met at 8 p.m. on the above date in the Parish House. All members of the Vestry elected at the Annual Congregational meeting held December 14,1957, were present, including the Treasurer and the Register for the old Vestry.

The meeting was opened with prayer by Mr.Stitt, who

presided.

The minutes of the last Vestry meeting were approved as read. The Register then was called on to read the appropriate section of the minutes of the Annual Congregational Meeting dealing with the election of the new Vestry.

The next order of business was organizing the Vestry for 1957. The following nominations were made and duly seconded:

For Senior Warden: J.M.MIchaux

For Junior Warden: C.R.Kennon Jr. and Wm.R.Richardson

For Register: J.P.Jervey Jr.

For Treasurer: E.Strudwick Jr.

A motion was carried closing the nominations. Wm.R. Richardson requested that his name be withdrawn from the list in view of the fact that because of pressure of his business he was unable to devote the time required by the duties of the Junior Warden.

The following officers were elected to serve for

1957:

Senior Warden: JM.Michaux
Junior Warden: C.R.Kennon Jr.
Register: J.P.Jervey Jr.
Treasurer: E.Strudwick Jr.
Asst.Treasurer:J.P.Jervey Jr.

The Treasurer's report was received and ordered filed.

Under old business, J.M.Michaux reported that the
acquisition of the St.James property by St.Lukes Church had
been accomplished, and that after reserving the dwelling and
one acre of land, the balance of the property had been sold
to Mr.G.W.Spring Jr.at a price of \$500, a check for which amount
was deliveded to the Treasurer. He stated further that the
dwelling was in need of certain repairs. Colonel Quintard,
for the Vestry, and General L.P.Collins were appointed a
committee to look into the matter and report back with an
estimate.

Colonel Quintard reported that the pump at the Parish House was water-logged and that he would require some help to drain the pump. A motion was carried authorizing him to hire such help as he needed.

A motion was carried continuing the committee appointed by the Senior Warden to obtain suitable memorial plaques to be installed in connection with the \$1500 donation from the Ladies Aid Society. Vestry Meeting, January 7,1957, Continued.

The Committee was instructed to present designs and estimates for the plats to the Vestry for approval.

A motion was carried authorizing the Treasurer to have the Church accounts audited by a certified public accountant.

A motion was carried giving precedence to work on the Parish House grounds over painting the ceilings in the Parish House.

There being no further business the meeting adjourned at

9:15 p.m.

The Vestry met at 8 p.m. on the above date in the Parish House. Messrs. Michaux and Richardson were absent.

The meeting was opened with prayer by Mr. Stitt.

The minutes of the last meeting were approved as read.

Under old business Col. Quintard reported that he and General Collins had inspected the dwelling on the old St.James property and that in their opinion the building was not worth the cost of repairing and painting it. After some discussion it was decided to defer action until a later date.

Colonel Quintard also reported that he had drained the pump at the parish house but that such remedy was temporary, and he recommended purchase of a hoseand such fittings as would make it possible to siphon the tank easily at intervals. He was author-

ized to take necessary action in the matter.

E.Strudwick Jr., Chairman of the Committee appointed to obtain stitable memorial plaques in connection with the recent gift of \$1500 from the Ladies Aid Society, reported progress was being made. He outlined suggestions for wording and mentioned firms best qualified to do the work.

The Treasurer reported that the audit of his accounts by a certified public accountant had been completed but that no bill

had been presented so far.

Colonel Quintard reported progress on the driveway in front

of the church and on the grounds clean-up.

Under new business, the election of a Treasurer to succeed Mr. Edmund Strudwick Jr. was discussed at some length. Some months ago Mr. Strudwick had advised the Vestry that he would be unable to continue as Treasurer inasmuch as his doctor had told him that the work placed too much additional strain on his eyes. The Vestry therefore reluctantly agreed to find a successor. Colonel Quintard nominated Mr.E.T. Janney for the position. Mr.C.R. Kennon Jr. seconded the nomination. There being no further nominations, Mr. Janney was unanimously elected. It was agreed that the Senior Warden should notify Mr. Janney of his election, in view of the fact that the Senior Warden had gone to great effort to find a qualified successor to the present treasurer.

A resolution was carried unanimously by the Vestry thanking Mr.Strudwick on behalf of the entire congregation for the splendid work done by him during his tenure as treasurer of St. Lukes, and the Register was directed to spread this resolution

on the minutes. Mr.J.M.Michaux was elected delegate to the Annual Council and the Senior and Junior Wardens were designated a committee to select an alternate.

A motion was carried approving the sponsorship by St.Lukes

of a Boy Scout Troop and a Cub Pack.

Mr. Stitt next presented the report of the Churchyard Committee. The following items were approved:

1. Construction of a driveway across the front of the church. 2. Enlarge the parking area to theeast of the church, 20 feet. 3. Provide a driveway to the rear door of the parish house,

and a parking lot there.
4. Planting of a large shrub on either side of the parish

house front entrance.

(Vestry Meeting, March 26,1957, continued)

5. Plant American Box bushes by walks.

6.Plant periwinkle along walks.

7. Construct trellis with climbing rose to conceal oil tank.

8. Thin out and clean up woods behind churchyard.

A further recommendation to cut a gate-way through the walls of the churchyard leading to both parking areas, including iron gates and brick walks, was upon motion deferred until a meeting of the full membership of the Vestry could be held, at which time an estimate of the cost would be available; the motion further directed that work of building the brick walks to the front gate be held up pending the decision of the Vestry.

A motion was carried authorizing the Treasurer to close out the capital account and to transfer the balance to the operating account, and further directing that prior to starting any phase of the churchyard program, an estimate of the cost be presented to the Treasurer.

The Treasurer stated that in his opinion there no longer was any need for carrying workman's insurance on the parish house, and a motion was carried authorizing him to discontinue it.

There being no further business, the meeting adjourned at 10:00 p.m.
