This indenture made this 24<sup>th</sup> day of July 1843 between Wm. H. Harrison and Deborah his wife of the one part and Richard S. Gilliam Jno. H. Holman and Richard W. Royster (all of the County of Powhatan) Trustees in Trust for the uses and purposes herein after mentioned of the other part. — Witnesseth that the said Wm. H. Harrison and Deborah his wife for and in consideration of the sum of sixty two dollars and 50 cents to them in hand paid the receipt whereof is hereby acknowledged, have given, granted, bargained, sold, aliened, conveyed and confirmed and by these presents do and each of them doth give, grant, bargain, sell, alien, convey and confirm unto the said Richard S. Gilliam Jno. H. Holman and Richard W. Royster and their successors one acre and a quarter of land, lying in the County of Powhatan and bounded as follows, on the North by the road running by Pine Creek Mills, on the West by the land of Daniel Stimpert on the South and East by the land of said Wm. H. Harrison with all and singular the appurtenances and privileges thereto belonging To have and to hold the said acre and a quarter of land and its appurtenances unto the said Rich. S. Gilliam Jno. H. Holman and Rich. W. Royster their successors in Office for use in Trust for the use & benefit of the Members of the Episcopal Church according to the Rules and discipline which now from time to time be agreed upon and adopted by the Ministers Preachers and Members of said Church, and in further Trust and Confidence that as any one or more of the Trustees herein before mentioned shall die or refuse to act, then and in such an event it shall be the duty of the Stationed Minister to call a Meeting of the remaining Trustees as soon as conveniently may be and when so met the said Minister shall proceed to nominate one or more persons or persons to fill the place or places of him or them whose Office or Offices has or have become vacated as aforesaid, and the said Trustees so assembled shall proceed to elect and appoint the person or persons so nominated to fill such vacancy or vacancies. And the said Wm. H. Harrison and Deborah his wife do and each of them doth by these presents warrant and defend unto the said Richard S. Gilliam, Jno. H. Holman and Richard W. Royster and their successors chosen and appointed, as aforesaid from the claim or claim of all persons whatsoever. — In Testimony whereof the said Wm. H. Harrison and Deborah his wife have hereunto set their hands and seals the day and year aforesaid. —
